Assembled Chemical Weapons Alternatives Program proposes to construct and operate three Static Detonation Chambers at the Pueblo Chemical Depot. The chambers safely treat and destroy chemical munitions, energetics, and associated waste items using indirect heat.

The Pueblo Chemical Depot has applied for a Class III Permit Modification, Request No. 19-005, to construct and operate three Static Detonation Chambers.

Items addressed in this permit modification request include:

- The location, general process, types of waste generated and managed by the Static Detonation Chambers
- Off-gas treatment systems—thermal oxidation, spray dryer, baghouse filter, wet scrubbers and carbon filtration
- Change in the use of three interim permitted storage igloos to waste storage of munitions (igloos G101, G102, and G103)
- Change in the operator of two igloos for storage of hazardous waste (igloo H1102 and H1103)
- Change in the operator and permitting additional roll-off storage area for storage of scrap metal and hazardous waste in roll-offs and drums
