The mission of the Program Executive Office, Assembled Chemical Weapons Alternatives (PEO ACWA) is to safely destroy the chemical weapons stored at the Blue Grass Army Depot in Kentucky and the U.S. Army Pueblo Chemical Depot in Colorado. In order to successfully accomplish this mission, PEO ACWA is overseeing the design, construction, testing, operation and closure of pilot-test facilities at each of these locations.

The storage and elimination of the chemical weapons stockpiles can serve as an economic opportunity for a community. This rings true for the communities of Richmond, Kentucky, and Pueblo, Colorado, where PEO ACWA administers the chemical weapons destruction facilities. The continued storage and destruction mission will take several years and require local workforces. PEO ACWA is committed to tapping into local businesses and workers to support its destruction mission.
