**What is the
purpose of these
permit
modification
requests?**

The U.S. Army and its contractor, Bechtel National, Inc., operate the Pueblo Chemical Agent-Destruction Pilot Plant (PCAPP) that is currently destroying munitions containing mustard agent stored at the Pueblo Chemical Depot. The Colorado Department of Public Health and Environment issued the Research, Development, and Demonstration Permit on July 1, 2004.

The Army and Bechtel are now applying for the following Class 2 Permit Modification:

Modification No. 95, Inspection Plan Change in Preventative Maintenance Frequencies and Update

This modification corrects and clarifies language, corrects typographic and formatting errors; incorporates into Table K-15 changes from Permit Modification Request No. 92 and incorporates into Table K-16 changes from Permit Modification 0017-1WOA.

In Appendix K-1, corrects the job plan number for the monthly preventative maintenance of the Standby Diesel Generators; corrects an error in a job plan reference for a diesel-driven fire water pump; and removes reference to electric pallets jacks from Job Plan PMM-A-M80-004 as the Pueblo Chemical Agent-Destruction Pilot Plant (PCAPP) has decided not to use electric pallet jacks for the movement of munitions or energetics.

In Appendix K-3, revises the frequency of select preventative maintenance on Systems B01, B02, B04, B05, B06, B20 and B24.

In Attachment E, revises the Job Plan number for the annual preventative maintenance of the fire water hydrants and updates the titles and revision numbers of documents to be consistent with the Inspection Plan or PCAPP's document management.

This Permit Modification Request requires revision of Attachment E, *List of Drawings*, and Attachment K, *Inspection Plan*.
